- 1. Executive Session: The executive session was canceled and not held.

Steve reported the Omnisite system at the Star Gas Lift Station was placed back into service on July 3<sup>rd</sup> due to bad sensors that needed to be replaced. Steve also reported the influent pumps at the WWTP had to be removed and serviced due to clogging of the impellers (debris was stuck in the pumps). The pumps were pulled and placed back into service.
