### Action Items:

- 1. **Executive Session:** An executive session of the Board was held prior to the start of the regular meeting. The executive session was held to discuss ongoing litigation. No action was taken during the executive session. The executive session ended at 8:45 am.
- 2. September 15, 2023 HCRSD Board Meeting Minutes: Motion made by Darin Duncan, second by Bill Byrd, to approve the meeting minutes. Motion approved unanimously.

- 3. Berkshire WWTP Expansion Project: Bob Woosley informed the Board the IDEM Construction Permit obtained for the project requires that construction begin by January 20, 2024. If the start of construction will be delayed the District must request an extension of the permit. Based on the delays anticipated with the project it is unlikely that construction will begin by that time. A motion was made by Charlie Crawford, second by Darin Duncan to allow Heritage Engineering to file a request with IDEM to extend the permit. Motion approved unanimously.
- 4. Berkshire WWTP Operations Report (September): Aaron Tolliver presented the September operations report. All parameters were met for the month of September. Aaron mentioned that there were a couple of instances of erroneous influent flow meter readings due to the presence of grease at the influent bar screen causing blinding of the screen resulting in water backing up into the influent line. The grease was coming into the plant in large chunks which was likely coming from the gravity lines at the mobile park (all other flow is pumped which would make the presence of large chunks of grease difficult given they would have to find their way thru a pump to reach the plant). Aaron also mentioned that UV season ends at the end of this month and they would be pulling the bulbs to be placed in storage. He also noted they are in need a few replacement bulbs that they intend to purchase in the coming days. A motion was made by Bill Byrd, seconded by Gary Davis to accept the September operations report. Motion approved unanimously.
- 5. Lanesville Interchange (Capacity Fees): Herb Schneider informed the Board the Town of Lanesville recently increased their capacity fees. An increase was needed due to the growth of the area and the need for expansion of the Town's WWTP. Herb suggested the Board considered an increase in the District's Capacity Fee to better align with the Town's current fee (the District's fee is significantly less than the Town's fee). The Board agreed with Herb's recommendation and requested that Chris Byrd and Bob Woosley work on a new rate ordinance to be presented to the Board at the next meeting.

#### 6. Treasurers Report

- **a. Treasurer's Report:** Gary Davis presented the Treasurer's Report. *Motion made by Darin Duncan, seconded by Bill Byrd, to approve the Treasures report. Motion approved unanimously.*
